#### **POSITION FOCUS**

Under the direction and supervision of the Principal/Director and the guidance of a teacher/Learning Coach, the Educational Assistant provides physical, social, emotional, behavioral and learning support to students/children identified with mild, moderate and/or severe needs in a variety of settings within the school environment

### **POSITION EXPECTATIONS**

### **General Employee Expectations**

- 1. Provide a high standard of professional performance.
- 2. Serve as a positive role model and team member.
- 3. Adhere to confidentiality and ethical guidelines.
- 4. Engage in ongoing professional learning to enhance and broaden their knowledge, skills and abilities.
- 5. Recognize they are employed in a position of trust and have a responsibility to act accordingly.

#### **Student Support**

- 1. Provide flexible support to students/children according to their changing needs.
- 2. Assist the teacher in designing and implementing individualized or group programs to meet the varied needs of identified students/children, while supporting other students/children, whenever possible.
- 3. Facilitate and encourage independence in all areas of student/child development.
- 4. Maintain data collection to support student/child learning.
- 5. Demonstrate understanding of the diversity of student/child learning strengths and needs.
- 6. May be required to support the diverse physical and/or medical needs of students/children. Including, but not limited to:
  - Supervision and supports with toileting routines
  - Supervision and supports with eating routines
  - Supervision and supports with daily medical needs (as recommended by physician)
  - Supervision and support with dressing
  - The ability to lift as determined by physical therapy
- 7. Assess and appropriately respond to the physical and emotional needs of students who demonstrate challenging behaviours. Including, but not limited to:
  - Calming and regulating students engaged in challenging behaviours (crying, yelling, etc.)
  - Supervision and supports for aggression towards others (hitting, biting, etc.)
  - Supervision and supports for self-injurious behaviours (hitting, biting self, etc.)

- Supervision and supports for students engaged in destructive behaviours (throwing, breaking, etc.)
- Supervision and supports for students engaged in unsafe behavior (running, limited awareness of surroundings)
- 8. Perform other related duties, as required.

## School-Based Teamwork

- 1. Under the direction of the classroom teacher/Learning Coach, communicate with all relevant team members to provide/receive pertinent information that may impact/enhance student/child progress; review goals and assist the team with the development of new goals.
- 2. Demonstrates the flexibility, organization and high energy required to fulfill the role of an Educational Assistant.

### **Professional Responsibilities**

- 1. Support a positive learning environment for all students/children.
- 2. Support the safety of the students/children in the school and the community.
- 3. Demonstrate continuous learning in the areas of learning support, inclusive of the use of appropriate educational technologies and positive behavior supports for students/children.
- 4. Display collaborative skills, including cooperation, shared decision making and open communication.

# Educational Assistant - Grid Level I

- High School Diploma
- Related experience and the ability to work effectively with students and staff in a variety of learning needs is preferred.

# Educational Assistant (Certified) – Grid Level II

- Educational Assistant Certificate or Diploma, a related equivalent postsecondary diploma program, or
- High School Diploma and a minimum of one (1) year post-secondary course study; or
- The successful completion of a minimum of 300 hours of professional development relevant to the employee's current job description; Alternatively,
- Five (5) years of full-time employment with the board will be recognized as meeting this requirement; or a blend of post-secondary coursework and relevant professional development that meets or exceeds the requirements will also be considered.
